Dear Directors of Texas Appleseed:

Attached are an April 7, 2015 letter to Texas Appleseed and an August 31, 2015 letter to the Superintendent of the McKinney Independent School District (MISD). The first pertains to a March 2015 Texas Appleseed Report titled "Class, Not Court – Reconsidering Texas' Criminalization of Truancy." The second pertains to August 11, 2015 letter from Texas Appleseed and the NAACP Legal Defense and Educational Fund (LDF) to the Superintendent of MISD regarding MISD discipline practices.

The two letters explain that the central premise of the Texas Appleseed March 2015 truancy report and the organization's recent letter to MISD is the exact opposite of reality. That is, both the truancy report and the letter to MISD reflect the view that reducing adverse outcomes will tend to cause a decrease in the proportion racial minorities and other disadvantaged groups make up of persons experiencing those outcomes. In fact, reducing the frequency of an outcome tends to increase the proportion such groups make up of persons experiencing the outcome.

The two attached letters explain in detail why this occurs. A few references are also listed after the signature below. The first four explain the issues relatively succinctly (though with a focus on the fact that reducing an adverse outcome tends to increase relative differences in experiencing of experiencing, which necessarily means an increase in the proportion the disadvantaged group makes up of persons experiencing the outcome). The remainder address the issue rather more elaborately.

Texas Appleseed has advised that it does not agree with my April 7 letter to it, which suggests it will also not agree with my recent letter to MISD. I don't know the basis for the disagreement. But the central point of the two letters, like the central point of the references below, is hardly debatable.

In fairness to Texas Appleseed, the misunderstanding reflected in its March 2015 truancy and recent letter to MISD is widespread, if not almost universal, among persons examining demographic differences. References 11-13 are letters to the Departments of Education, Justice, and Health and Human Services and the government's Chief Data Scientist addressing the same misunderstanding by the federal government as that found in the Texas Appleseed truancy study and letter to MISD. Reference 5, particularly in the latter pages, explain that similar misunderstandings are pervasive in the world's leading universities. But persons or entities sharing these misunderstandings do so simply because they have not yet thought the matter through. Eventually they will think it through.

Meanwhile, it cannot serve the public interest for Texas Appleseed to promote actions by governmental entities that will tend to achieve the opposite of what Texas Appleseed maintains they will. Moreover, the organization's actions involving this failure of understanding can undermine its credibility with regard to activities that may not involve similar issues.
